#### Scope and Content Note

This collection of contracts, letters, lists, ledgers, and other memorabilia is a rich documentation of the Beauregard Monument Association in post-Civil War New Orleans and provides a thorough history of an organization deeply devoted to preserving the memory of "Louisiana's Son" and Civil War General Pierre Gustave Toutant Beauregard.

Born in St. Bernard Parish, Louisiana on May 28, 1818, General Beauregard received many honors as a soldier and a great leader during the Civil War. He died on February 21, 1893 in New Orleans, Louisiana. On the night of his death, several prominent New Orleans civil leaders (and former confederate soldiers) who were members of St. Paul Camp no. 16 of the U.C.V. (United Confederate Veterans Association) thought that it would only be fitting to have a monument dedicated to General Beauregard. The Beauregard Monument Association was founded; it was incorporated on February 23, 1893. For twelve years, the members of this association meticulously planned, budgeted, and raised the funds for this monument by investing in city bonds, sponsoring events, charging membership fees, and by accepting donations from various individuals and other organizations. Over the years of its existence, several of the associations' members died or resigned. In 1913, Mr. Alex Doyle, a sculptor from Connecticut, was commissioned to make the statue of General Beauregard. Eventually, the organization raised over \$22,000.00 for the creation and erecting of the statue and its foundation. On November 11, 1915, the Beauregard statue and monument was dedicated at the entrance of City Park in New Orleans, Louisiana.

This collection contains several original contracts between the association and several local businesses and individuals, association certificates and stationary, several timelines and speeches, and correspondence between the organization's members and various individuals. Many of the papers within this collection were written in blue or purple ink; it is thought that these different ink colors (rather than the standard black or led pencil) represent duplication of documents and are copies created by the various authors. It is also believed that this collection was created and maintained as official organization documentation by General A.B. Booth, Secretary of the Beauregard Monument Association.

The actual donor of this collection is unknown; therefore, there are no restrictions on the copying or duplication of items within this collection.
