Historical Background

Brigadier General Carl L. Trippi was a native of New Orleans born July 11, 1926 (Camile Trippi). He began his military career as a private in the Army in 1943. He was on active duty during World War II, where he served in the Philippines. He rose to the rank of Sergeant before being discharged from the Army in 1946.

He then joined the Louisiana Air National Guard in 1946. He completed pilot training at Reese Air Force Base Texas, graduating first in his class in 1952. He held many positions during his career with the Louisiana Air National Guard including Deputy Chief of Staff, Chief of Staff, and Assistant Adjunct General. He received many promotions including full Colonel and eventually to Brigadier General.

Throughout his life, he has flown F-100, F-102, jets, piston engine aircrafts and helicopters. In civilian life he was a manager of aircraft operations for Chevron Oil. He married Rita Stumpf. The couple had a daughter, Susan. Brigadier General Carl Lawrence Trippi died on March 21, 1981. For more detailed information, refer to the military documents folder #1 for his biography.
